Thank you for your interest in **Champion Event Travel LLC** and its affiliates (collectively, “we,” or “us”). This document (the “Website Privacy Policy”) describes how we collect, use, and share your Personal Information in association with [www.championeventtravel.com/](http://www.championeventtravel.com/) (the “Site”). The Website Privacy Policy does not apply to Personal Information we collect, use, and share in other contexts, such as when providing our air travel and ancillary services. By continuing to use the Site, you accept and agree to be bound by our Terms of Use and acknowledge the practices described in this Website Privacy Policy. ### **Changes to the Website Privacy Policy.**

### **Collection of Personal Information.**

Personal Information you provide to us. We collect Personal Information that you provide directly to us, such as your name, home or other physical address, email address, telephone number, communications you send us, and other generalized background information. In this Website Privacy Policy, “Personal Information” means any information relating to an individual or an identifiable individual.

Personal Information we collect automatically. We and certain third parties automatically collect certain Personal Information when you visit the Site. We may collect this Personal Information using “cookies,” which are small text files that the Site saves and accesses on your computer using your web browser, or other web tracking technologies. The Personal Information that we automatically collect includes the following:

- **Device information**, such as information about the computer or mobile device you use to access the Site, including the hardware model, operating system and version, Internet Protocol (IP) address, unique device identifiers and tokens, unique identifier headers, mobile network information, your general geographic location, your browser type, and other information that identifies you as the user of the device or the person providing information to us; and
- **Log and usage information**, such as the referring page that linked you to us (e.g., another website or a search engine), the sections of the Site that you visit, any search terms you enter on the Site, and how you interact with our digital content. We may use digital tools, such as analytics tools, to understand how individuals interact with the Site and to diagnose problems.

Personal Information we collect from third parties. We may also obtain Personal Information about you or your use of the Site from third parties, such as our vendors (like web hosting providers, analytics providers, and advertisers), business partners, and social media companies. The Personal Information we obtain from third parties depends on your account/privacy settings with those third parties and the third parties’ privacy policies. You are responsible for reviewing the privacy policies of such third parties and adjusting your settings to meet your preferences.

We may process the Personal Information we collect to infer your interests or preferences.

### **Our Use of Your Personal Information.**

We use the Personal Information we collect on the Site to operate and improve the Site, to offer a positive user experience, to exercise and defend our legal rights, to support our business operations, to comply with legal and regulatory requirements, and to deliver the services that we provide. We may use your contact information in order to send you emails or other communications regarding our services

We may, directly or through third parties, serve ads regarding products and services intended to be of interest to you on the Site and on third-party sites or apps. We and others may use cookies and similar technologies to make inferences and predictions about your characteristics, interests and preferences based on your online interests and activities across other sites, and we may combine the information we collect via cookies with other information that you provide to us. We may also use technologies to associate and recognize your various mobile and desktop devices in order to deliver ads and other content in a consistent manner across the devices you use. #### **Disclosure of Personal Information to Others.**

We use vendors and service providers for a variety of business purposes to help us offer, provide, and bill for the services we provide. We share your Personal Information with such vendors and service providers as reasonably necessary for them to perform work on our behalf.

We disclose Personal Information with our subsidiaries, joint venture partners, or other companies that we control, that control us, or that are under common control with us. We do not sell your Personal Information for money, but we may disclose your Personal Information to certain third parties in exchange for obtaining services, such as targeted advertising or digital analytics. We may also disclose your Personal Information to third parties that we work with to host events, provide ground transportation, accommodations, meals, or other services associated with the packages we offer for purchase on the Site, or deliver other offerings.

We will also share Personal Information with companies, organizations or individuals if we have a good faith belief that access, use, preservation or disclosure of such Personal Information is reasonably necessary to: (1) satisfy any applicable law, regulation, legal process or enforceable governmental request; (2) enforce our [Terms of Use](#), [Operator-Participant Contract](#) or other contractual rights; (3) detect, prevent, or otherwise address fraud, security or technical issues; (4) protect against harm to our or others’ rights, property or safety; and (5) in connection with the consideration, negotiation, or completion of a corporate transaction in which we are acquired by or merged with another organization or we sell, liquidate, or transfer all or a portion of our assets.
